RESOLUTION NO. 2019-03

A Resolution establishing a Detention Center Excess Revenue Fund

WHEREAS, from time to time, the Chase County Detention Center generates revenue in excess of expenses, and

WHEREAS, "Excess Revenue" shall mean those funds that were generated by Detention Center operations that are collected and on hand that equal more than the amounts required to pay, in the aggregate, for expenses to operate the detention facility over the preceding three months, but not more than \$6,700.00 per month, and

WHEREAS, said excess revenue should be transferred to a separate fund in order to set those funds aside for proper accounting and application to other Funds, as appropriate, and to provide the Chase County Commission with sufficient information about the extent of such excess revenues, and

WHEREAS, money from said Fund may be transferred from time to time to another Fund upon action of the County Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CHASE COUNTY COMMISSION, IN REGULAR SESSION ASSEMBELED, That the Chase County Detention Center Excess Revenue Fund is hereby established, with the following provisions:

- 1. This fund is designated as the CHASE COUNTY DETENTION CENTER EXCESS REVENUE FUND and assigned Fund No. 200.
- 2. Excess Funds, as defined above, shall be transferred to said Fund No. 200 on or about the last business day of a given month.
- 3. Any money transferred to this Fund may be transferred to other Funds from time to time as authorized by the County Commission and reflected in the Minutes at which the Commission so authorized.


