WHEREAS, upon separation, the said handbook defines what earned but unused vacation and sick pay shall be paid to an employee; and

WHEREAS, the County Commission considers it necessary to clarify the meaning of these provisions.

NOW, THEREFORE, BE IT RESOLVED BY THE CHASE COUNTY BOARD OF COUNTY COMMISSIONERS, IN Regular Session assembled in the Courthouse of said County at the seat of government thereof, that:

- 1. The County Commission hereby clarifies that an employee shall be required to provide two weeks' written notice to the employee's department head of intent to resign.
 - 2. "Two weeks" shall mean 14 calendar days. And shall not be Vacation and/or Sick Time used.
- 3. Any employee who fails to provide sufficient written notice as required by the said Handbook (as herein clarified) shall forfeit his/her entitlement to payment of any vacation and/or sick leave.
 - 4. The County Clerk shall post this Resolution to the County's official copy of the said Handbook.
